The above named Order made on 11 August 2021, if confirmed as made, will modify the definitive map and statement for the area by recording a footpath of a variable width commencing at a junction with Alton Road, proceeding westwards through the grounds of Abbey House, then south-westwards to Beacon Hill Cottage, continuing south-westwards to Beacon Hill Farm and a junction with Exton Footpath 508. The footpath continues, bearing north-westwards to a junction with Warnford Footpath 502.

Please state the grounds on which they are made.

- c) the discovery by the authority of evidence which (when considered with all other relevant evidence available to them) shows
 - that a right of way which is not shown in the map and statement (i) subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path.

The authority has consulted with every local authority whose area includes the land to which the Order relates.

Hampshire County Council hereby orders that:

- 1. For the purposes of the Order the relevant date is 22 April 2021.
- 2. The Hampshire Definitive Map of Public Rights of Way and The Hampshire Definitive Statement of Public Rights of Way (Dated 15th December 2007) shall be modified as described in Part I and Part II of the Schedule as shown on the map/s attached to the Order.
- 3. This Order shall take effect on the date it is confirmed and may be cited as The Hampshire (Winchester City No.52) (Parish of Warnford) Definitive Map Modification Order 2021.

A new footpath with a variable width of between 1.5 and 7.3 metres. Commencing at a junction with Alton Road (A32, Point A on the Order plan) and continuing in a westerly direction through the grounds of Abbey House and a pasture, into a field, then in a south-westerly direction through fields to Beacon Hill Cottage and through the cottage grounds to the parish boundary (Point B). Continuing in a south-westerly direction along a track to Beacon Hill Farm and a junction with Exton Footpath 508 (Point C), then in a north-westerly direction along field boundaries to the parish boundary and a junction with Warnford Footpath 502 (Point D).

1.5 metres wide between Points A and B. A variable width of between 3.3 and 5 metres wide between Points B and D, as shown by grey sharing on the Order map.

A total length of 1,215 metres.
