#### **CERNE ABBAS BURIAL GROUND**

#### POLICY AND PRICING CHARTER

The fees payments and sums fixed and settled under Section 15 (I) of the Local Authorities Cemeteries Order 1977, with effect from 1st January 2022.

The fees, payments and sums set out below apply where the person to be interred or in respect of whom the right is granted is, or immediately before his/her death was, an inhabitant or parishioner of the Parishes of Cerne Abbas, Godmanstone, Nether Cerne and Up Cerne (or in the case of a still-born child, where at least one of the parents is, or at the time of the interment was, an inhabitant or parishioner).

There are to be no exceptions to this rule.

**INTERMENTS** Fee

The fees indicated do not include the digging of the grave.

- 1. for the interment, in a grave, regardless of whether an exclusive right of burial has been granted
  - of the body, or the cremated remains, of a still-born child, or of a child whose age at the time of death did not exceed 12 years.

For the right to erect or place on a grave or vault, in respect of which the exclusive right of burial has been granted: The design of a memorial must have the prior approval of the Parish Council. Only Portland, Purbeck or Hamstone may be used.

c.	A footstone not exceeding 3 feet in height	£ 130
