1. Welcome and Apologies

The Chair welcomed everyone to the meeting. Apologies were received and accepted from Cllrs. Gomez and Holowczycki, and County Councillor Richard Palmer.

3. Minutes of the Previous Meeting

1. New Village Hall Plans – to update council members regarding the interior fitment of the hall: A Teams meeting was held with Bellway Homes to discuss the interior fitment of the village hall, and they advised the parish council that they have no obligation to fit the interior of the village hall. However there is a condition attached to the hybrid application, Condition 13:

"The 'village hall' hereby approved shall be constructed, fitted out and ready for use prior to the occupation of any dwelling not located on phase 1A (as shown on figure 6.1 in the Design and Access Statement) and shall only be available for use between the hours of 0700 and 2300 on Sunday to Thursday and between the hours of 0700 and 0000 on Friday and Saturday."

Bellway Homes have requested the village hall committee's 'wish list' is sent to them which the Clerk has provided. Send to all council members.

The parish council supports this application.

2. 25/503659/FULL: Change of use of land for siting of 6no. huts for overnight stay visitor accommodation, erection of associated ablutions building and parking, along with a change of use from an agricultural building to a rural worker dwelling. Land At Raspberry Hill Lane Iwade Kent ME9 8SP.

Council members object to this application for the following reasons: Increase in traffic will have a negative impact and Inappropriate development - no need proven. The parish council request a holding opposition on the above application and reserve the right to add to the above comments. The parish council request this application is considered by the Planning Committee

3. 25/504438/HYBRID: Section 73 - Application for variation of conditions pursuant to planning permission ref: 25/500824/HYBRID to make amendments to approved plans condition 4 (to allow changes to the design of the country park), and variation of conditions 5 (country park landscape details), 7 (to allow delivery of the country park in phases), 24 (landscape and boundary to country park), 26 (surface water drainage masterplan), 27 (surface water drainage details), 30 (infiltration), 43 (ecological mitigation strategy), 44 (detailed ecological mitigation strategy), 46 (landscape and ecological management plan), 47 (habitat creation plan), 50 (lighting plan) and 57 (biodiversity net gain). Land East Of Iwade Iwade Kent ME9 8ST.

Appendix A – Report from County Cllr. Richard Palmer

Activity during October and November

Main local issues have been appeals and representing resident on school places and transport appeals plus SEND transport –

On Monday's citizenship award at Oakfield House

Attended a meeting working of the Kent Coroners service

Chaired the Kent & Medway Military Partnership Board looking at how the military and businesses and the community work together – reservices and cadet

Attended Kent police looking at how they manage armed incidents to use of dogs in drugs

Attended the Justice Service at Canterbury Cathedral

Attended the Lord Mayors civic service in Canterbury

Kent Children services award (Chris)

Held the great public service event in Maidstone

Attended the Lord Lieutenants award in Tonbridge

Attended the Rochester Festival of Remembrance

Remembrance Service in Canterbury Cathedral

Roadworks and potholes – important people are encouraged to report as many as possible plus poor roads. KCC are now starting to fix stretches/sections of roads as well as busily fixing pothole.

KCC Budget – ASC is currently overspent – However the administration is looking at better ways of commission plus working jointly with the NHS in Kent and Medway to help reduce costs. The abandoned caravan on Iwade Road has now been reported and the police are aware and have an interest in it.

A big KCC project was to bring the Eurostar back to Kent. After organising and hosting an event held in September with interested parties It has been confirmed that Virgin Trains will be taking on the service, and they have given their assurance in writing that the Eurostar will resume services at Ashford and Ebbsfleet.

Education is stretching budgets particularly SEND and transport – KCC is looking at send provision and the high costs of Transport

Integrated children's services – some provision is being brought back in house owing to the high cost of private provision – this will save a minimum of 1.5 million a year. If all goes well this is a project that can be expanded on. The first property has been identified, purchased and is Swale. The home is a 2 bedded unit and will be for Kent looked after children with profound difficulties.

Recruitment drive on fostering families following the launch of a short film commissioned jointly with other authorities "Run". A hard-hitting film highlighting the enormous benefits a foster family can make to a child's life. The film is available to watch on YouTube.

KCC are working on a new project in the youth justice system, around restorative justice. More to follow.

KCC are working with the CEO to get a cap removed for in-house apprenticeships for social workers. This will enable us to recruit more and rely less on expensive agency staff.

Looking at changing the policies around ECHP's assessment for the armed forces.

KCC Youth Voice hosted an event at Detling Showground, The Big Mental Health Conversation, showcasing the work being done to support people suffering with mental health issues.
