Dear Mr. Bishop,

This week we received a Statutory Notice referring to the road (Black Drift) crossing our land in Necton signed by the Swaffham Rights of Way officer, Mr L. David Ormerod. I have enclosed a copy of the notice.

This Statutory Notice proposes to classify this road as a Restricted Byway.

This notice raises several concerns for us.

Why has Swaffham Town council engaged itself with matters concerning a road within the parish of Necton?

Why has there been no consultation with local businesses and residents before this application was made?

Is Swaffham Town Council aware that Black Drift is a Norfolk County Council Maintained Highway?

Registering Black Drift as a Restricted Byway thereby prohibiting mechanically propelled vehicles would prevent access to 2 residential properties, 2 business premises and would prevent direct access to approximately 60 hectares of agricultural land.

We have contacted Norfolk County Council to express our concerns and to make them aware that an application has been made to restrict use of their highway. We would also like to hear from Swaffham Town Council regarding the circumstances for this application and how we may appeal against it.

It should be very clear that should this application be successful the effects on our business and neighbours will be severe and we will seek legal redress to cover costs incurred.

We look forward to a prompt response.


