Minutes of the Parish Council meeting held in Shrawley Village Hall

400 Apologies for absence:

The Chairman welcomed everyone to the meeting and pointed out following the last meeting we now had 4 vacancies on the Council as both Councillor's Honan and Griffin had resigned. She stated it was a very critical time for Shrawley Parish Council and invited members of the public present to consider the opportunity of representing their community by sitting as a councillor.

401 Confirmation of the Minutes:

The minutes of the previous meetings held on 11th November 2019 as circulated earlier were approved and signed by the Chairman.

402 Declaration of Interest for a) The Meeting and b) Any Changes to be notified to the Registers of Interests and Gifts & Hospitality

403 County & District Councillor's Report

County Councillor Grove had submitted a written report. District Councillor Pam Cumming informed the Council Malvern Hills District Council, which currently had 38 Councillors, had written to the Boundary Commission in England to consider looking at the current disparities with the number of elected councillors in various sized wards in Malvern Hills. Some District Councillors had single member wards and others were 3 member wards. The MHDC were awaiting a decision by the Boundary Commission.

She informed Council Mr Jack Haggerty the Joint Chief Executive of Wychavon DC and Malvern Hills DC was due to retire in July 2020.

404 Planning Applications Update and for Consideration

There was one Planning application 19/01901/HP Associated Ref:19/01902/LB for a Single storey garden extension at Barn Owl Cottage, Sankyns Green, WR6 6LQ. The Chairman stated all councillors would look at this over the next few days and give the Clerk their views.

405 Correspondence & Update Sheet

There was no additional correspondence to be considered.

406 Community Grants

The Council noted the applications for a Community Grant for 2019-2020. **It was RESOLVED to give grants to the following organisations;**

- Nora Parsons Day Centre - £50.00

407 Precept for 2020-2021

The Council considered a draft work document produced by the Clerk as likely expenditure for 2020-2021. The document projected various items for consideration where likely expenditure which had previously been discussed by the Council over the past 12 months could occur. The Council considered it was very important to continue to support local community groups with grants together with improving the village environment with regular grass cutting and visual improvements for the betterment of the villagers. It was also felt important the Parish Council had a committed reserve fund allocated for future unforeseen circumstances. Following a proposition, **it was RESOLVED to set the precept for 2020-2021 at £8,000.**

408 Finances

The Clerk confirmed access to the Barclays Bank accounts or the Online Facility had still not been resolved. The Chairman stated she would need to address this issue as Councillor Dymond was not a signature on any of the Barclays accounts.
