

## Scheme of Delegation for Clerk

## Notes

- No parish councillor may act independently; all parish council actions must be by way of the full council or the clerk.
- 2. Delegation for urgent business is a necessity and is included below.
- 3. The Parish Council's Standing Orders and Financial Regulations are based on NALC models.
- 4. The Clerk, as the council's 'Proper Officer', is also the council's Responsible Financial Officer (RFO).
- 5. Due to the size of Chadwick End Parish Council the Clerk is the only paid officer; The Chair has been specifically identified as an individual who can be delegated to act on the Clerk's behalf in their absence or in the event that the Clerk is an interested party.
- 6. This scheme of delegation is not comprehensive and is subject to being implemented in

Service area	Function
Audit	To maintain a continuous internal audit that is to be available for members to review on a monthly basis.
Communications	Delegated to Cllr Davies
Consultations	To notify the Council of all planning application consultations received. In the event that the PC cannot meet before the comments due date for a planning application the Clerk, in consultation with Cllrs, will make the decision.
Contractors	To liaise with, and be the first point of contact for, all contractors appointed by the parish council.
Decisions	To take all necessary action, including signing any document, necessary to give effect to any decision of the council and its scheme of delegation.
Elections	To notify the Returning Officer of all casual vacancies arising in the membership of the Council as required by statute and to liaise with them regarding any statutory notices, electoral arrangements and co-option.
Emergency Plan	To report to council issues concerning emergency planning to facilitate and enable an appropriate response in the event of a local emergency

Proper Officer	To act as Proper Officer for the purposes set out in Standing Orders and for all other purposes prescribed by law.
Staff	There are no other members of staff for whom the Clerk is responsible.

Standing Orders	<ol> <li>To adhere to the Standing Orders of the council.</li> <li>Arrange for biennial review.</li> </ol>
Urgent business	1. Urgent decisions required between scheduled meetings are delegated to the Clerk in consultation with the council's Chair
	<ol> <li>In the absence of the clerk or in the event that the clerk is an interested party, she will be substituted by an appropriate substitute from outside the parish council, ideally a clerk from within the same district or The Chair</li> </ol>
	<ol> <li>In the absence of the council's Chair, or in the event that the council's Chair is an interested party, she will be substituted by the vice Chair.</li> <li>Decisions made under this delegation will be reported to and minuted at the next council meeting.</li> </ol>
	<ol> <li>Under this delegation, where appropriate, the clerk may conclude that an extraordinary meeting of the council be called to deal with the urgent matter.</li> </ol>
