182/23 PRESENT:

Cllrs Adam, Boswell, Gibson, Newton, Robertson, Tippen and Turner (in the Chair). The Clerk was also in attendance.

184/23 APPROVAL OF PREVIOUS MINUTES:

The minutes of the meeting held on 21st February 2023 were agreed and signed as a true record.

175/23 PLANNING APPLICATIONS WITHIN MARDEN PARISH

23/500410/FULL - Pond Oast, Tanner Farm, Goudhurst Road, Marden

Installation of boiler vent including introducing native planting to the area of garden in front of the outlet to assist in screening the vent and relocation of 2 roof lights (part retrospective)

23/500411/LBC - Pond Oast, Tanner Farm, Goudhurst Road, Marden

Listed building consent for the installation of boiler vent including introducing native planting to the area of garden in front of the outlet to assist in screening the vent and relocation of 2 roof lights (works started)

Both the above applications were discussed together.

Marden Parish Council would normally resist applications for installation of roof lights in oast cones but the principle in this case was established in the approved application MA/11/1723 and MA/11/1724. Therefore, Cllrs raised no objection for 23/500410/FULL and no objection provided the Conservation Officer is in agreement for 23/500411/LBC.

23/500830/FULL - Storage Barn, Admiral Way, Marden

Removal of existing storage barn and erection of 1 detached three bedroom dwelling with associated parking and landscaping (resubmission of 22/505439/FULL)

Cllrs discussed this in detail and although noted the reduction of footprint and the provision of more amenity space continue to recommend refusal and wish this to go to MBC Committee if minded to approve.

Reasons for refusal:

Out of keeping with the street scene;

Footprint still has a cramped and oppressive external environment to the north, west and south elevations;

Would fail to achieve high quality design;

Surface water management has not been addressed.

This application is therefore contrary to Maidstone Borough Council Local Plan Policies SP5, DM1 and DM5 and Marden Neighbourhood Plan policies BE1 and NE1.

Cllrs also wished it noted that the east and west elevational drawings appear to conflict with those of the north elevation. Together with the roof plan not reflecting the details in the elevations.

23/500846/SUB - Staplehurst Transits, Staplehurst Road, Marden

Submission of details pursuant to conditions 3 (soft landscape scheme) and 5 (biodiversity enhancement scheme) of application 22/503981/FULL. Cllrs noted application.

23/500926/SUB - Westlands Oast, Summerhill Road, Marden

Submission of details to discharge condition 3 (materials) of planning application 20/501145/FULL.

Cllrs noted application.
