

# East Drayton Parish Council

Minutes of a Meeting of the Parish Council held  
at 7.30pm on Tuesday, 18<sup>th</sup> January 2011 in the Village Hall

## Present:

Cllrs N Stanley, R Small, H Mackintosh, P Ogle, M Goddard and CCllr J Hemsall. In attendance: Clerk, S Pickard. Members of the public: 0.

- 1 **Apologies for Absence** – were received from Cllr Mrs A Stanley, Cllr I Stephens and Pc Bailey.
- 2 **Minutes of meeting held on 16<sup>th</sup> November 2010** - were approved and signed. Meeting scheduled for December was cancelled due to bad weather.
- 3 **Matters Arising**
  - a) Delivery of local services by Parish Council  
The Chairman advised that an engineer had been due to make an inspection before Christmas, but this had been overtaken by weather conditions. It was noted however that some potholes had been 'ringed' recently. The Chairman AGREED to contact Mr Gordon Albery again, who will oversee any remedial works in the village.
  - b) Overhanging branches  
Cllr Small AGREED to attend to the remaining work when the weather permits.
- 4 **Declarations of Interest** – There were no declarations.
- 5 **Correspondence**
  - Bassetlaw District Council
    - a) Review of the Dog Warden Service – it was AGREED to reply advising that the Parish Council had recently requested owners keep their dogs on leads when walking on footpaths (copy of the minutes recording the item to be sent). **ACTION: S Pickard.**
    - b) Register of Electors 2010-2011; To be placed in the Circulation folder.
    - c) Localism Bill; All information concerning this to be placed in the Circulation folder. Discussed, but AGREED this did not directly affect the village.

    - e) Request from Notts Police to send occasional email and attend a Parish Council meeting to discuss possible cuts. NALC at Southwell to be emailed with a list of monthly meeting dates.

- 6 **Planning**
  - i) Location: Summerfield, Low Street, East Drayton. *Proposal:* Proposed conversion of roof space into three bedrooms, en-suite shower room and WC. The Chairman confirmed the earlier decision that the Council had no objections to the proposal.
- 7 **General Business**
  - i) Community Speed Watch – Cllr Stephens had agreed to try and 'drum up' support but he had not met with much enthusiasm.
  - ii) Village Signs – proposed sketches not yet been received and it was AGREED to contact Jan at Nottinghamshire County Council, LIS. **ACTION: S Pickard.**

- ii) Bassetlaw District Council Precept and Grant application 2011-2012:  
After discussion the following figures were RESOLVED for the budget:  
The concurrent grant is confirmed at £267, this involves a precept requirement of £2,419. Application form to be completed accordingly. **ACTION: S Pickard.**
- iii) Snow clearing: It was AGREED to send a letter of thanks to Cllr Stephens for all his hard work and effort in clearing footpaths in the village. **ACTION: S Pickard.**
- iv) CCllr Hemsall advised that he was in the early stages of consultation regarding a communal snow plough blade and gritter. So far, negotiations have included Grove, Headon and Gamston villages. CCllr Hemsall AGREED to keep the Council updated on progress. Discussion followed regarding East Drayton' involvement and it was AGREED to contact the Council's insurers to enquire about third party liability. **ACTION: S Pickard.**
