## Minutes of the Parish Council Meeting held on Wednesday 4<sup>th</sup> September 2019 in the Village Hall, Weston commencing at 7.30 p.m.

190901 To receive Apologies for Absence and Declarations of Interest Apologies were received and accepted from Cllr. Francis, Cllr. Saddington and District Cllr. Michael. Cllr. Lowney sent apologies that he would be late arriving.

Declaration of Interest – Cllr. Chase declared an interest in agenda point 190908 (i) and Cllr. Lowney declared an interest in agenda point 190907 (iii)

Open Forum – ten minutes to receive questions and comments from members of the public
A resident thanked the Council for the recent street sweep along Main Street and the new bench.

• At this point in the meeting all agreed to discuss agenda point 190906 (ii) regarding grass verges in response to a resident query regarding the options available for managing verges around the village to encourage wild flowers and wildlife. It was noted that some neighbouring counties, e.g. Lincolnshire, have a policy of leaving verges for wildflowers, however this is generally not within village environments or a restricted speed area, i.e. 30mph. Highway safety being the primary consideration for the County Council, other considerations also include the control of ragwort and the views of other residents.

County Cllr. Laughton advised a trial was carried out in 2018 which did not produce true results due to the drought. A further trial is currently ongoing on the A6097 between Lowdham and Gunthorpe.

As the Parish Council has no jurisdiction in this matter, the resident was advised to contact NCC Highways for further guidance.

Cllr. Lowney joined the meeting at 7.45pm

i) Parish Clock – Time Assured have advised that the H&S queries have been resolved and a faculty is in the process of being requested for the work to be carried out.

190905 To receive reports from County Council and District Council Representatives County Councillor Laughton commented on the following:

• A meeting has been arranged with Highways England, Notts Police and Via EM to discuss the ongoing issues of trespass across farm land close to the A1

• Sutton-on-Trent Library has its re-opening on Friday 6<sup>th</sup> September at 2pm at the Methodist Centre

• One of the new road resurfacing 'Dragons' has been in operation in Egmanton

• The Minerals Local Plan is out for consultation. Focus is on extracted gravel being retained locally thus reducing transportation. The amounts of sand and gravel agreed for extraction over the life of this plan has been reduced from 31million tonnes to 19milion. An extension requested at the Cromwell site has not been accepted into the plan. The plan also includes oil exploration and fracking.
