

Cannock Wood Parish Council

Minutes of the Council Meeting

Commencing 7.30pm on Thursday 24 October 2019

Village Hall, Buds Road, Cannock Wood.

PRESENT: Councillors P.Ansell (Chair) K. Salter (Vice-Chair), I. Bamford, F. Frison, A. Green, S Janes and R. Poynton

Also present: Wendy Hollinshead-Acting Clerk, 6 members of the public.

ITEM 1: WELCOME AND APOLOGIES.

Cllr Ansell welcomed everyone to the meeting which began at 7.30pm.

There were no apologies.

ITEM 2: DECLARATIONS OF INTEREST

No Declarations of interest were received.

ITEM 3: PUBLIC PARTICIPATION

One member of the public addressed the Council concerning two planning applications within Cannock Wood. The resident was concerned that no opposition had been filed by the Parish Council when some residents had objected to the proposals. It was explained that the Parish Council could only object on limited grounds and neither application had met those grounds. Both applications fell within planning guidelines. Residents were referred to the Ward members who form part of the Planning Authority. Residents were also advised about the proposal to commence a Neighbourhood Plan and encouraged to join the committees which will be set up early next year.

One member of the public spoke about the garages on High Meadow. One block will be demolished, and an open parking area will be created. The resident was concerned that entrances to properties would be blocked during the work. A number for CCDC would be supplied but the experience was that it was inefficient and

caused problems for the residents. Cllr Salter agreed to try obtain a direct number for the residents to have obstructions moved quickly.
