# **Purchase of Exclusive Rights Privacy Notice**

When you purchase the Exclusive Right to a single or joint cemetery plot

The information you provide (personal information such as name, address, email address, phone number) will be processed and stored so that it is possible to contact you and to respond to your correspondence, provide information, send invoices and receipts relating to your burial plot. Your personal information will not be shared with any third party without your prior consent.

## **Information Security**

Ash-cum-Ridley Parish Council cares to ensure the security of personal data. We make sure that your information is protected from unauthorised access, loss, manipulation, falsification, destruction or unauthorised disclosure. This is done through appropriate technical measures and relevant policies.

We will only keep your data for the purpose it was collected for and only for as long as is necessary. After which it will be deleted.
