NOTICE is hereby given that the Kent County Council proposes to make the abovenamed Order under Sections 81, 82, 84 and 124 of the Road Traffic Regulation Act 1984, the effect of which would be to: -

The effect of the order would be to reduce the current national speed limit to 40MPH on the following road in Ramsgate, Thanet: -

SPRATLING LANE- From the current 40MPH speed limit at a point 16 meters from its junction with Saddlers Mews for a distance of 90 metres in a north westerly direction.

Road Traffic Regulation Act 1984

The Kent County Council as traffic authority propose to make the Order referred to above and as shown on the drawing accompanying this document as part of the new development for the following reasons:-

From 1 April 2013 Kent County Council became responsible for a number of Public Health functions. One of those was the health improvement for the population of Kent. In recent years the demand for the implementation of 20mph schemes had been increasing in response to both local and national campaigns, therefore Kent County Council are intending to implement 20mph Public Health Schemes in the following location, in Ramsgate, Thanet.

In addition, the various restrictions are to:-

- Avoid the danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising
- For preserving or improving the amenities of the area through which the road runs.

ROAD TRAFFIC REGULATION ACT 1984

THE KENT COUNTY COUNCIL, acting as Local Traffic Authority and in exercise of its powers under Sections 81, 82, 84 and 124 of the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act') as amended, and all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby propose to make the following Order.

- This Order shall come into operation on XX day of XXXXXXXXX 2023 and may be cited as "The Kent County Council (Various Roads, Thanet) (Speed Limits) (Consolidation) Order 2022 (Amendment No.4) Order 2022" ("this Order").
- 2. The Interpretation Act 1978 shall apply to this Order as it applies for the interpretation of an Act of Parliament.
- 3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, "The Kent County Council (Various Roads, Thanet) (Speed Limits) (Consolidation) Order 2022" ("the Order of 2022") shall have effect as though:
