Minutes of the Council Meeting held on Wednesday 20 April 2022 Waller Park Pavilion, Wood Lane, Darenth, Kent DA2 7LR

01/04/22: TO RECEIVE APOLOGIES FOR ABSENCE

Apologies for absence were received from Councillors Carey, Cook, Hicks and Holmes.

02/04/22: TO RECEIVE DECLARATIONS OF DISCLOSABLE PECUNIARY OR PREJUDICIAL INTEREST No declarations received.

03/04/22: TO APPROVE THE MINUTES OF THE COUNCIL MEETING HELD ON WEDNESDAY 16 MARCH 2022

RESOLVED: To approve, by majority agreement, the Minutes of the Council Meeting held on Wednesday 16 March 2022 as a true and accurate record.

04/04/22: URGENT ITEMS

The Chairman authorised an urgent item to consider replacement of the front door of the Waller Park flat. Members were presented with two figures: White PVC door - \pounds 920.98 and a brown external door - \pounds 1,125.46. Both prices are inclusive of materials and labour.

Replacement is necessary to ensure security of the property for safety and insurance purposes.

RESOLVED: By majority agreement, to install a replacement front door at the Waller Park flat at a cost of \pounds 1,125.46. The Clerk would authorise payment for the emergency purchase.

The Chairman took questions from the public.

Following the response to a question another member of the public left the public area and verbally attacked another member of the public, the Chairman, Clerk and Councillors. The intimidating nature of this behaviour forced the Chairman to suspend the meeting and he asked the disruptive member of the public for her name and the reason for her behaviour. However, the motive was not explained and the offender refused to provide her identity.

The three **PCSOs** in attendance offered their assistance, which was welcomed by the Chairman.

With the Chairman unable to continue the meeting, the Clerk opened the door for the individual to leave and she was escorted from the premises by one of the PCSOs.

The Chairman then restarted the meeting and a second question was taken from the public, which the clerk committed to responding to by email.

Members had previously been provided with the March 2022 report from PCSOs Lewis and Prior. The details had been uploaded to the Parish website for public information.

PCSO Prior gave a verbal report regarding nuisance vehicles at three locations in Darenth. She explained that Section 59 Orders allow police to give drivers a warning if they are reported to have used their vehicle in a manner which causes "alarm, distress or annoyance". If reported to have done so again within a year the police have the right to confiscate the vehicle.

PCSO Prior extended an invitation to Parish Members to accompany the Neighbourhood Team on a 'walk-around' the Parish.
