No one had shown any positive interest in the Treasurer's post. It was noted that the hall would close on 2 June 2020 if these posts were not filled.

It was noted that the Tennis Club is having some re-surfacing work done and that permission had been given for plant/machinery to be parked on a cordoned off area of the car park. The Parish Council had no objection to an area leading to the tennis court being fenced off for health and safety reasons.
