7197/17 Casual Vacancy It was NOTED that a Casual Vacancy has been declared in the New Ash Green North West Ward following the disqualification of Cllr S Cornelius. If an election is not called, the Parish Council can proceed to fill the vacancy by Co-option. (Cllr Mrs Hobbs arrived)

7198/17 Planning a. Applications

SE/17/02663: 59 Seven Acres, New Ash Green, DA3 8RW – Demolition of sheds. Erection of a two storey rear and part side extension. Cllr Mrs Connell PROPOSED that the Parish Council objects to this application on the following grounds.

The size and bulk of the proposed extension.

Over development of the site.

Close proximity of the proposed extension to the neighbouring property no. 55 Seven Acres, resulting in loss of privacy.

The proposed extension would create a five bedroom dwelling. Local knowledge suggests that a study already exists in the garden in a lean-to not shown on the plans.

The property would not have sufficient on-site parking capacity in regard to the increase to five bedrooms. There is only a single garage and one parking place allocated to this property and there is already a problem with street parking in this neighbourhood. There is no visitor parking on this neighbourhood.

SE/17/02176: Woodlands, Oak Farm Lane, Fairseat, TN15 7JU – Demolition of existing dwelling and the erection of a replacement dwelling. SE/17/02865: 2 The Row, New Ash Green, DA3 8JB – Application for consent to cut down, prune or uproot trees covered by a Tree Preservation Order. Cllr J Kelly PROPOSED that the Parish Council objects to the application as it stood until further information is received and that any work carried out should be under the supervision of the Sevenoaks Tree Officer. SECONDED: Cllr Mrs Brammer and UNANIMOUSLY AGREED. (Cllr Mrs Connell returned to the room at 20.07)
