To this could be added Cross Park; the verge by Cross Park; Shelduck Close buffer zone; the Avery Way woodland and the footpath running through it; Village Hall car park and the Brimp. Cllr Skudder said he would contact Simon Swift of Medway Council about the possibility of taking on Medway Council's greenspaces responsibilities in the parish as a devolved function and Andy Freeman of Turfsoil Ltd who were the contractors for High Halstow Parish Council.
