5. LANDSCAPE & CHARACTER ASSESSMENT -

Mr. C. Howlett reported that good progress was still being made with the Landscape & Character Assessment. Cllr. G. Willis had taken a number of photographs around the Parish to illustrate the character features that will be identified within the report which include architectural features, colour palates and environment settings. It is anticipated that the writing of the document can commence in the near future and interested Members were invited to attend a working group to initiate the writing stage.

6. WILDLIFE & HABITAT SURVEY -

The Clerk reported that work was in progress and the initial mapping exercise should be complete by next week.

7. PREPARATION OF THE DRAFT NEIGHBOURHOOD PLAN -

Members discussed how to approach writing the draft Neighbourhood Plan to ensure that a concise, eloquent document could be achieved. It was noted that the wording of the policies would be supported by Cheshire Community Action, therefore particular focus should be directed to drafting the context and justification of each of the policy areas. It was considered that a content listing should be drafted to guide the next stages of writing.
