9 Allotments

The 2 half allotments on West Clint field have been rented to Nick Adams and Callum Guy. The land has been ploughed and the fence has been put up. The gate will bill be completed by 17th May. We need to create an access for the allotment holders. Cllr Carlisle suggested a ladder style. Cllr Brown was asked to make this style quickly and at a reasonable cost so that we can get it up as soon as possible. Approved by Cllr Hughes, seconded by Cllr Wake.

Minor repairs have been carried out on the west wall of the east allotments.

Cllr Carlisle received a phone call from Mr Todhunter, who subsequently sent an e-mail to the clerk. Clerk has invited Mr Todhunter to the Annual Parish meeting so that allotments can be discussed. Clerk has spoken to Mr Todhunter and sent a brief reply and invitation to the meeting. Clerk asked to send a reply to Mr Todhunter addressing the issues of the drain, which was not on our land, and to let him know we will inspect the walls.

The Tenancy agreement was discussed and clerk to make the following amendments:-The word Tenant to be changed to User, Lease be changed to Agreement and Rent to Payment. A new sub clause to be put in reading: No cultivation to take place within 2m from any drystone walling. Clerk to amend for proof reading at the June meeting.

Andrew Lacey paid £3.00 in cash for his allotment.

Clerk provided a breakdown of Income and Costs for West Clint Field and the Allotments. Clerk to amend with projected costs of £830.00 and bring to the next meeting.

Denise Marmont has asked to go back onto the waiting list as she would like a larger plot.
