#### 420 11 INTERNET/BROADBAND ACCESS AT CROSS PARK/THE BRIMP

There does not appear to be any reduction for charitable/youth purposes so the proposed installation at Cross Park would be £3,230 (Brimp cost awaited. It is likely to be more expensive). A wireless alternative will be investigated when there is sign of COVID19 rules allowing public access again.

#### 421 12 PLANNING

- a) Allhallows Planning Applications: None
- b) Medway Local Plan Housing Infrastructure Fund plans for new access to Wainscott Bypass, New Rail service to Hoo and country parks had been discussed at the Rural Liaison

#### 422 13 HIGHWAYS AND FOOTPATHS

- a) Parking Restrictions No update, ongoing.
- b) Footpath Officers Report Cllr Bowley reported on his continuing clearance works in Cross Park, Recreation Ground, Shellduck Woods, Avery Way Wood (Path) and footpaths.
- c) Verbal contributions Cllr Bowley had provided a detailed report that had been circulated.

Car parking fines had been issued for illegal parking (Stoke Road/Allsaints Road). Access for footpath RS12 to Yacht Club would benefit the footpath network (RS12 just ends at a fence) but access across Bourne Leisure land would be required).

d) A site meeting with the Chair and Medway Cllr Filmer had been held to examine damage to local roads. The Medway Council Highways Department had assessed the work as non-critical, but they agreed to carry out works in the next financial year (April 2021).

## 423 14 CROSS PARK ISSUES

- a) Governance Issues New trustees had been registered with the Charity Commission. Bank arrangements are being changed (in the meantime urgent bills are being paid by the Parish Council and will be refunded in full when access to the bank account has been resolved). Access to bank statements/account details is required to update the Charity Commission filing and establish the finances.
- b) Expansion of Facilities Progress being monitored.
- c) Building/Land Issues Cllr Bowley's monthly report was circulated. Kent Wildlife Trust to be approached advice re. the site (and invasive brambles) and the possibility of a new Management Plan.
- d) Electrical Inspection Inspection complete, but issues with mains supply and extension to the temporary changing rooms remain outstanding and to be resolved when the works at Kingsmead (Allhallows) Park are progressed and the s106 money for the Cross Park extension is available.
- e) Consideration of Allotments in Cross Park The Chair has suggested that allotments could be provided in Cross Park. Primary issues would be security of site, provision of water supply, management (Allotments Society), change of use from public access. Further investigation required.

#### 15 YOUTH CLUB/YOUTH

a) Youth Club –Future Planning – Volunteers are still cleaning/re-organising the club. Equipment repairs/re-organising underway. A new pool table from an HMRC office that is closing down in Maidstone had been secured and will need to be collected.

- a) ALLHALLOWS PACT Cllr Morrice No meetings.
- b) KALC (Medway) Cllr Morrice was unable to attend the ZOOM meeting. An additional rep. was now required Cllr
- c) Medway Council Rural Liaison Cllr Mrs K Draper A ZOOM meeting had been held. There was an emphasis on Community Planning for the villages and traffic management report had been produced, especially with regard to HGV vehicles accessing the new Amazon site (not enough on-site parking, so vehicles parking up in local roads around the site – generating waste and lack of toilet facilities).
- d) Village Hall Cllr Lovatt None Their AGM had been cancelled due to COVID19 restrictions. There has been Judo sessions on Saturdays. The annual Sleigh through the village is being considered but there are issues with COVID19 restrictions.
- e) Cross Park Cllr Freeguard Reported previously.
- f) Village Fete Cllr Forrest A village wide draw has been arranged.
- **g)** Friends of All Saint's Church Cllr Forrest There is further work on the Heritage Lottery Fund application/grant. There is also a Peninsula wide HLF application, previously led by RSPB, but now Medway Council.
