The Chair reported that the MP has picked up the issue of illegal quad bikes and off road vehicles in the woods which is causing issues in Elkesley and other areas; as always please continue to report any sighting to the police. The Police & Crime Commissioner has invested a lot of money into rural policing, £150,000 invested into APR cameras; four new 4 x 4 vehicles for this area to run alongside of the current 5 off road bikes and 2 quad bikes.

It was noted that there has been a lot commercial fly tipping around the area.
