### Bobbing Parish Council - Annual Parish Meeting Wednesday 3rd May 2017

## Parish Council Chairmans report

Thank you and welcome for attending, many of you are now regular and familiar faces to parish meetings.

Bobbing Parish Council serves the communities of Bobbing Village, Howt Green, Rooks View, Watermark, Key Street, Keycol and Bobbing Hill plus parts of Grove Park and the Meads. Plus the rural areas on the Western side of the Parish. An area with neighbourhoods but without a 'traditional' village centre.

During the past year the parish council held 12 regular meetings plus the Parish Council AGM. All the meetings were held in the Village Hall usually on the first Wednesday of the month. It has been a busy year and I am pleased to say we are now a full council with 2 new councillors.

Much of the discussion at BPC meetings this year has been centred around traffic, parking and contentious planning issues. As you are aware Bobbing is divided by 3 'classified roads' one of which is a trunk road (A249) with two multi-level interchanges, it is also under pressure from developers to develop houses, which in turn brings further traffic related issues. The Parish Council is doing what it can to resolve some of these issues and it contacts SBC, KCC, Kent Highways and Highways England to resolve others. The main issues are inconsiderate parking, parking and driving on footpaths, litter being dropped, fly tipping, lorry parking, speeding and verges being eroded. Almost every road has a different problem often caused in the first place by lack of foresight when obtaining planning permission. However, I could go on all night, but I won't.

Away from traffic, other more local events have been going on often with happier outcomes.

Southern Water have finally resolved their mains water leaks in the Grove Park area.

We have supported the popular Rosemount archology digs at Rosemount in Grove Park.

We have successfully objected to new housing development of 100 housing west of the A249.

We have produced some newsletters, albeit irregularly, is anyone interested in helping with this?

We have made responses on consultations regarding the Lower Thames Crossing, Kent Highways Freight Action Plan and the Housing White Paper.

We are attempting to install 2 new parish notice boards, one at Grove Park and the other at the Shops on the Meads.

Bollards have been installed in Hilton Drive to deter driving on the footpath.

We have also made representation to BT regarding Broadband speeds.

Bobbing Church has received support with events it has organised.

Also the Bobbing PC has revamped its website which I urge you to use.

Finally I want to thank the local PCSO and Community Wardens for their information and support they give the Parish Council. They may not always make meetings but they do send reports and are available on the end of a phone.

Looking forward, if we survive the two elections in the next few weeks I hope the parish council will serve the residents as best as time and resources will allow. The parish council will endeavour to keep the Parish a presentable and pleasant place to live. However, one thing can be guaranteed, residents may sometimes disinterested in local issues but will always take an interest in their immediate neighbourhood and make contact if they want to know what is going on, especially if it is impacting on their lives. Finally it is good to see more members of the public attending and interacting at meetings.

## Regular ongoing concerns (not an order of priority):

Key Street roundabout, pedestrian safety, traffic speed, traffic gridlock.

Keycol Hill, pavement parking.

Bobbing Hill, cars, parking and speeding signs.

Bobbing Village, speed reduction past village school/village hall/church.

Gadby Drive, cars parking on dangerous hill/bend.

Hilton Drive, cars parking (Grove Park School run times).

Everywhere, Litter, fly tipping, and wrappers by food shops.
