3. MINUTES OF THE PREVIOUS MEETING

The previous meeting minutes of the Assets and Amenities Group held on 24th October 2023 were agreed as a true record of the meeting.

4. PUBLIC REALM IMPROVEMENTS

a. ORGARSWICK JUNCTION

Cllr McCreedy gave an update on the outstanding work to be completed at the Orgarswick junction area. Target for planters and planting to be completed by mid Feb ready for an official unveiling. Maybe an option to add additional seating in the future, council to review use of area once completed. Options for solar lighting for new tree to be researched.

b. SEAWALL

Latest update on drop kerb is that this should be completed by end Feb, delayed due to the poor weather, members discussed improvements to disabled access to the benches and agreed to relocate a bench and picnic table to allow better wheelchair access. J Penfold to be asked to replacing missing paving slab when drop kerb completed.

5. SEAWALL BENCHES

Members reviewed the work/quote for winter maintenance on the seawall benches and agreed to **recommend to full council that only urgent work is completed at this time.** Cllr McCreedy to prepare updated list of urgent works for approval by full council.

Members to discuss 2024 Parish Council led events

D-DAY 80th Anniversary – Need to convert beacon or buy stand-alone version ready for the event. Existing beacon too close to new housing for lighting.

Bloomin Dymchurch – needs more publicity for 2024. Include in next newsletter and prepare posters for village shops to display

Seawall Holiday Workshops – Recommend to full council Living History Workshops are confirmed for Summer 24 on same basis as 2023.

Christmas window/garden displays -extend the competition to residential garden displays for 2024 to be judged by the Parish Council

Christmas Carols Singing evening – Plan for 6th/7th December further details TBC

Diary of Events on website, noticeboards – Office to promote any local events notified to the Parish Council on Parish Council website diary and central noticeboard.

7. SUMMER BASKETS & PLANTING

Members to discuss arrangements for 2024 high street hanging baskets. High Street premises to be leaflet dropped to confirm if they are willing to be responsible for a basket.
