The Chair suspended the meeting to allow members of the public to speak.

#### 3324/20 To receive reports from the District & County Councillors

District Cllr Kevin Dukes gave his District Council report:

Things are moving on quickly at the moment; the council has been engaging with the Health Authority and Government regarding the Covid situation we are in at the moment; plus looking at what would happen if there were further restrictions. The reason why we are in tier 2 is because of our proximity to Sheffield and Doncaster; which have very high Covid-19 rates. Bassetlaw has just over 100 per 100,000 people with Covid. Bassetlaw Hospital is being reserved where possible for operations that are non Covid related, so Doncaster are sending people there for recovery and trying to keep Bassetlaw as clear as possible.

A couple of things that attention is required by the parish councils:

The government has issued a white paper on planning; it is worth a look because it does have some things in it that may affect Elkesley, particularly those of you involved in Neighbourhood Planning. It does seem that the White paper is suggesting that the Neighbourhood Plan will no longer carry as much weight as before, it is a bit light in certain areas as well; there is consultation happening at the moment up to the 29<sup>th</sup> October. The paper seems to be a developers charter and we need to be careful what you are agreeing to if signing up to this White paper; Cllr Dukes would urge everyone to read the white paper and respond, as rural villages, particular those on edges of rural conurbations could end up being overwhelmed, particular in Elkesley's case - if Gamston Airport is sold once the airport review is over, we need to be aware that it will be a prime development site according to the government.

Bassetlaw District Council's Local Plan will be coming out for consultation at the end of the Month, the next round of consultation will be in place for the Local Plan. It is important that everyone has a look and responds to the consultation and has their say in it.

Minutes of the meeting held 20th September 2020 Signed: J Skelton 17th November 2020

The Local Plan will involve a Garden Village on the other side of the Five Lane Ends roundabout; which will affect things for Elkesley. The Parish Council response needs to ensure that whatever work Highways England does to the A1; that it includes some kind of noise sound barrier for Elkesley. Part of the Planning for the new village will include increasing the speed on the A1 back to 70mph; after sorting out the Gamston junction.

Also relaunched is the Rural Plan which had been put on hold, but should be back out for consultation in two or three months, review of the new Bassetlaw rural plan in the beginning of next year.

Nottinghamshire was not included in the first round of the government reorganisation to form a unitary authority. The government is pushing to pass more responsibility down to parish council level. We need to know as a Parish council what this means, there isn't a lot of detail on it at the moment and how will that affect the Parish Council's responsibilities. It looks like they may reorganise parishes into much bigger entities; so parishes will be merged together. Elkesley is already a member of Bassetlaw's South East Parish Forum, which seems to be the type of size that the government is talking about; we need to be a strong member of the forum if we want to have a voice.

Cllr Dukes is a Trustee of the food bank and reported that it has been engaged with what is called the Bassetlaw Hub, through the Bassetlaw Volunteer Community Service. If anyone knows of any Harvest Festivals that may have spare food which is not allocated yet; the hub will be grateful of anything food; particularly as the need for food is in demand as the furlong scheme slows down.

It was also noted that County Councillor Kevin Greaves has chased up the work required to pot holes on Park Lane and around that area, Via are looking at that; however, not a lot of work is being carried out in the county at the moment; it is not a high priority at the moment.

Cllr May joined the meeting during the above agenda item.
