14/783 Election of a Chairman

It was proposed by Cllr. C.F. Smith, seconded by Cllr. S. Reynolds and **RESOLVED** to elect Cllr. S.A. Watkins as Chair for the forthcoming twelve months.

14/784 Election of a Vice Chairman

It was proposed by Cllr. S.A. Watkins, seconded by Cllr. S. Reynolds and **RESOLVED** to elect Cllr. C.F. Smith as Vice Chair for the forthcoming twelve months.

14/785 Apologies

RESOLVED – to accept apologies from Cllr's. K. Hanmer (family commitments) and Cllr. M. Hanmer (work).

14/786 Disclosable Pecuniary Interests

There were no Disclosable Pecuniary Interests declared.

14/787 To receive budget information

RESOLVED – to carry forward £329.57 from last year to give a total of £1529.57 for year ending 31st March 2015.

14/788 Grant Applications

- a) **To consider a grant application from Hands Around the Wrekin**

RESOLVED – not to award a grant on this occasion.

- b) **To consider a grant application from Wrockwardine Wood Arts Academy.**

RESOLVED – to award a grant of £100 towards funding the Senior Choirs trip to Italy in July.

- c) **To consider a grant application from Age UK, Donnington Day Centres**

It was noted that this application was for funding an Easter trip and it was **AGREED** to invite them to apply for a grant for a future activity.

- d) **To consider a grant application from Telford & Wrekin Council Summer Playscheme**

RESOLVED – to cover the cost of the school hall for the Playscheme in August.

14/789 Holy Trinity Churchyard

- a) To consider quotations received for fencing at the side of 2 Gibbons Close.**

It was AGREED to consider this item at the next meeting as no quotations have been received to date.

- b) To receive a letter from Mrs. Dorricott regarding maintenance of the Churchyard.**

Mrs. Dorricott expressed concern over the grass left in the churchyard after it has been cut, she said that the grass had been left all over the place, even on the lengths where the paths are supposed to be and she cannot understand why it cannot be collected. Mrs. Dorricott also expressed concern over curb stones that have been erected when they were told they could not have curb stones when they had two family stones erected. The Clerk pointed out that permission for stones would be the responsibility of Rev. Stafford.

It was AGREED to obtain quotes for maintenance of the churchyard, including collection of the grass, for April 2015.

Cllr. Reynolds suggested that the grass could be collected and placed in the bin in the churchyard to keep costs to a minimum.
