#### 2309/25) To receive and approve apologies and reasons for absence

#### 2311/25) To receive the Chair's report

The Chair reported that after several months of procedures, the responsibility for maintenance of the closed churchyard has now been transferred to Bassetlaw District Council (BDC). It is understood there will be six cuts per year.

The repairs to the A1, slip roads etc are ending, with the improvements noted.

Councillors have been making repairs to equipment in the play area.

Recent damage to a bench in the playing field was reported to PCSO Hollie Marsh.

Juliet Webber, Nottinghamshire Police's rural and wildlife crime partnerships manager, has offered to look for funds to replace the bench.

Several incidents involving fires have also been reported to the police. Residents are encouraged to report any antisocial behaviour online

#### 2312/25) To receive reports from the District and County Councillors

Cllr Kelvin Wright reported that plans for the Unitary Authority need to be with the Secretary of State by November. The new County Council is carrying out reviews of Highways, ViaEM and county finances. He confirmed the Councillor's grant was still open for applications from local parishes.

Cllr Charles Adams reported that six fires at the travellers site within the last month had occurred, resulting in Fire Services attending. He reiterated the need to report any antisocial behaviour either to the police or Crimestoppers <a href="https://crimestoppers-uk.org/">https://crimestoppers-uk.org/</a> or phone 0800555111. The District Council is waiting to see if an appeal will be lodged against the refused planning application. He also reported that an appeal had been lodged following the

refusal of the planning application for the solar farm off A614. Three small modular reactors are planned, creating 4000 jobs, and ensuring better power transmission for the local area.

#### 2313/25) To suspend the meeting to hold a 10-minute public session

A resident wanted to share a recent incident that had caused her to make a report to the police. Whilst walking her dog late one evening, she and her husband had been subjected to frightening and intimidating behaviour by several young men on scooters and in a white van. The parish council thanked her for bringing the matter to their attention, and reporting it promptly. Several other incidents were discussed with suggestions for the root of the problems.

Another member of the public was a representative from Gamston with West Drayton and Eaton Parish Council, wanting to show support for Elkesley's issues and offering to co-operate in joint efforts to address neighbouring matters.

#### 2314/25) To receive update on the Neighbourhood Plan review

Cllr Adams gave a brief update on the Neighbourhood Plan. The plan will be discussed at the District Council meeting in September, and the Parish Council will share the outcome as soon as possible.
