The conditions re drainage and soakaway are being addressed. It was considered that Condition 25 has not yet been met.

The car parking area appears to be changed from the original plan. We will send a letter to WDC on the matter.

Mr Emmett asked if we could apply to have a Tree Preservation Order on the two old oak trees near the entrance to the Lane.

d. Chilterns AONB Planning Conference.

Mrs Acres and Mrs Wallis attended this and Mrs Wallis gave a summary of the event.

e.WDC Local Plan Stakeholders' Meeting

Mrs Brownridge, Mrs Wallis and Mr Hutchings attended this and Mr Hutchings had sent a summary to the Parish Council for circulation.

111/13 ABBOTSBROOK HALL

a. Car Park fees

One resident has paid and another has indicated their intention to do so. A letter to the non-payers will be sent. Gate closures will be implemented. A notice may be placed on the gate when closures take place.

b. Deep Clean

Mr Fitchew and Mr Emmett will look at the hall to ascertain the need for a deep clean.

c. Minor Maintenance Works

The missing tiles on the roof and ridge need replacing. Mr Fitchew has received a quote for ± 516 inc VAT for these works, and it was agreed that it should be done as soon as possible.

The gutters need clearing and the groundsman will be asked to do this.

112/13 BURIAL GROUND

a. Purchase of a Memorial Records Book.

We do not need to purchase this as other methods of record keeping can be used.

b. New Area

Work on this will start 28th October 2013.

a. Repairs to Outside of Pavilion

The markings on the areas that need attention have faded. Work will now have to wait until Spring 2014. Mr Emmett can supply contractors' names.

b. Footpath Request

A request had been received from Little Marlow Cof E School for a footpath to be constructed around the west and south sides of the Recreation Ground. As this would impinge on other users, it was not approved with 7 votes against.

A letter will be sent to the school to advise them of our decision.

114/13 SPADE OAK CAR PARK

There was nothing further to report.

115/13 BUS – EXTENSION TO SERVICE

It has been proposed to extend the service to include a Saturday morning and funding for this has been agreed by the Chepping Wye Valley Local Community Partnership. The service would be welcomed by Westhorpe residents, but very little time would be allowed in Marlow, and concerns were raised about the accessibility of the roads in Little Marlow on a Saturday morning. The bus will be mentioned by Mrs Wallis at the Little Marlow Residents' Association meeting on Wednesday 23rd October. We need to respond to BCC by midday Friday.
