We have had many villagers ask us what we can do to reduce speeding on this road, as it's a straight stretch out of the village, I think drivers put their foot down slightly too early! In fact the other day, a resident's cat was killed on this stretch by a driver going too fast.

Back in December 2020, when the traffic survey was done, the data showed that this stretch was a bad spot for the village, and some sort of intervention would be warranted.

We are happy to purchase the SID ourselves, but obviously want to check you're happy for us to, and to seek your advice on the best place for it.
