## Minutes of the Parish Council on Monday 2nd November 2020, 7.30pm held by teleconference

  - (i) the need for the KCC project on speeding control on the Headcorn Road to cover the whole stretch from the village sign near Wren's Nest to near the junction with Crumps Lane. It was agreed that, the Chairman will discuss a speed limit on the whole length of Headcorn Road with the Chairman of Headcorn Parish Council and report back.
  - (ii) The deteriorating state of Headcorn Road between Foxes earth and Crumps Lane. It was agreed that this will be reported to KCC with a request that they inspect by walking the road rather than driving along it.
