.1 C6 ODIHAM RD BY DUKES MEADOW

Riseley 30 mph speed limit signs have moved as promised, but no new signs added. Have added two new posts either side of the road. Speedwatch sign by playground is no longer there. No real indication that traffic is adhering to the new limits.

Highfield PARK - cleared bushes away from signpost and painted. Church Lane needs the same treatment (JA suggested after meeting).

A30 signage for roundabout closure in Hook is thought OTT and affecting local business (DK comment post meeting).

Very bright street light reported outside home of DK but no action yet.(item added post meeting).

62 Chairmans Notes

Overall the number of issues in Heckfield is low: Our usual issues of Flytipping / Litter and 22 Church Lane continue. Village Hall finances are tight and we discussed & agreed the potential for a subsidiary from Parish funds whilst fuel prices are high and bookings low.

We agreed the precept to remain the same for the coming financial year, which is a reduction in real terms.

Remembrance Service: Wreath was laid by Brenda - suggested that we have a village event next year and work with the Church - good idea and positive feedback to the

concept.

Wellington Estate: Having issues with Wellington Country Park - fencing along Devils Highway now with Hart Enforcement Officer. Recent noise issue's reported to Parish Council dealt with by resident and Country Park management

The Devils Highway - investigate if and how we can get this landscape protected
