MINUTES OF A FULL COUNCIL MEETING HELD ON MONDAY, 6th DECEMBER 2010 at 7.30pm IN THE LANGTON GREEN VILLAGE HALL

10/169 DECLARATIONS OF LOBBYING: Cllr Mrs Podbury had been contacted by a number of residents regarding the precept but did not express any opinions.

10/170 MINUTES: The Minutes of the Full Council Meeting held on **1**st **November 2010**, having previously been forwarded to Members, were approved and signed.

The Minutes of the Extraordinary Full Council Meeting held on **29**th **November 2010**, having previously been forwarded to Members, were approved and signed.

10/171 PUBLIC OPEN SESSION:

Jeremy Sterling said he thought the Parish Council should not get involved with matters such as Highways. Chris Ponsford stated that she thought that £115,000 should be the maximum precept and not a suggested figure as recorded in the minutes of the meeting dated 29th November. She said that many people would be willing to volunteer and save Parish Council expenditure. Mike Bender said that Langton Green Sports Club will help with cleaning and maintenance of the pavilion but would like some more storage space. Miles Phillips stated that he is still unhappy with the 98% increase without consultation. John Jeffrey said he is still concerned about reserves and contingencies and is also now concerned about the highways measures required for Speldhurst Local Needs Housing. Peter Ponsford stated that the Government advises restraint and he wants the precept reduced. He produced spreadsheets with drastic budget cuts showing a precept of £35,000.lan Danks referred to the KALC

40% recommendation and said that he disputes it. He is also worried about items of expenditure that might arise from the Speldhurst Local Needs Housing.

10/172 FINANCE COMMITTEE – Report by Clir Parker

- i) The clerk left the room. The clerk's overtime was APPROVED. The clerk rejoined the meeting.
- ii) Cllr Parker reported that there had been four email decisions by the Finance Committee. A payment of £500.00 to St Mary's Church Speldhurst towards Churchyard maintenance was approved. A donation of £50.00 to the Mayor of Tunbridge Wells Christmas Toy Appeal was approved. The subscription to the Woodland Trust was approved. Payment of £81.41 for the hosting of Speldhurst Village Website was approved.
 - Consideration and approval of the Precept for 2011-2012 Cllr Mrs Jeffreys invited all members to make any further points they felt were relevant. Cllr Wheeler said the Precept was discussed at length at the Finance Committee Meeting on 8th November and voting was 7-0 in favour of £133.900. Cllr Mrs Podbury said she had concerns about a precept of £133,900 and would like it reduced to £123,900 but not any lower. Cllr Ellis spoke in favour of £123,900. Cllr Langridge confirmed that he had proposed a precept in the region of £110-115,000 at the Extraordinary Meeting on 29th November. He accepted that there is always work to be done in the Parish but feels the lower figure showed constraint. Cllr Milner echoed Cllr Langridge's views and said volunteers should be helpful in keeping costs down. Cllr Mrs Waters said it needs to be considered that even small budget cuts could have an adverse effect on the community. Cllr Mrs Paulson-Ellis accepted that the Council had taken some criticism from members of the public but pointed out that they have every opportunity to attend Parish Council meetings but rarely do so. Cllr Brown said he doesn't believe the Parish Council should get involved in expenditure on items such as Highways and he will vote for the lowest figure. Cllr Mrs Hull said Parish Vision was always about involving the whole community and she would like to see the precept at £113,900. Cllr Pendleton reminded the council that there was a unanimous vote for a precept of £133,900 at the Finance Meeting, he would like this kept to, and Parish Vision was to establish residents' priorities. Cllr Mrs Soyke said the nicest thing she had heard all evening was the offer of volunteers from residents of the parish. She also pointed out that for a Band D property the difference of £10,000 between precept amounts equates to 42p/month. Cllr Parker stated that nothing apart from public views has changed since the Finance Committee voted 7-0 in favour of a precept of £133,900. He is concerned for the future if it is reduced and wants and supports a precept of £133,900. Cllr Mrs Jeffreys said she really appreciates all the offers of help; Parish Vision has produced lots of volunteers and long term goals. She respects what has been said by members of the public but the Council needs to consider the future. Cllr Mrs Soyke added that all Councillors want to be very careful about the precept and will continue to scrutinise all expenditure. Cllr Pendleton added that if the Finance Committee had been aware of the Football Club's offer in terms of Langton Green Pavilion the budget figure for this item could have been reduced.

The proposed amendment to £113,900 was voted on and defeated 5-7 with one abstention.

The proposed amendment to £123,900 was voted on and **CARRIED by 8 votes to 4** with one abstention.

Councillors then **RESOLVED** that the amended precept of £123,900 be submitted to TWBC for collection.

10/174 HIGHWAYS REPORT

- i) The ISS installations in Ashurst and Groombridge are already having a beneficial effect on traffic speeds.

Cllrs Mrs Soyke, Ellis and Parker re-joined the meeting.

10/178 CHAIRMAN'S REPORT: Cllr Mrs Jeffreys thanked those Councillors who placed poppy wreaths on Remembrance Sunday. She reported that she has met Mrs Law and there are no more unresolved planning issues. She attended the Parish Council Chairman's meeting on 2nd November where available funds for Heritage Projects were discussed; the land outside the Old Watson Hall may be eligible. There was also discussion regarding the QE2 Project – Playgrounds for the future. This will be passed on to the new Amenities Committee.

10/163 COMMITTEE REPORTS

- i) Governance Committee Cllr Mrs Jeffreys reported that there had been no meeting since the last Full Council meeting and that the Risk Assessment is in progress and should be ready for approval at the January meeting.
- ii) Planning Cllr Mrs Podbury advised that there was nothing to report.
- iii) Parish Vision Cllr Mrs Podbury reported that there had been a meeting on 12th November. After some discussion Cllr Mrs Podbury advised that the Terms of Reference will be amended and re-presented at the next Full Council Meeting.
- iv) Recreation Ground Cllr Ellis reported that there has been no meeting since the last Full Council meeting. The clerk reported that he has ordered the dog bag dispensers and an additional bin and had saved in the region of £450 by choosing a combi bin and bag dispenser.
- v) Footpaths Cllr Milner reported that the Container is being delivered on 7th December.
- vi) KALC Cllr Brown thanked Cllr Mrs Podbury for attending the AGM on 13th November. Cllr Mrs Hull advised that the Courier newspaper would welcome more news reports on local events.
- vii) Local Needs Housing Cllr Wheeler reported that a committee meeting was held on 5th November together with a meeting with ERHA. It was **AGREED** to accept the offer from TWBC that Langton Green residents will be eligible for 3 of the houses on the Middlefield development. Cllr Mrs Hull reiterated that she considers TWBC Policy is fragmenting the Parish. A consultation for Site 15 LNH in Speldhurst is to be held on 16th February 3-7pm in Speldhurst Village Hall. Cllrs considered that there should be an additional date with possibly varying times too.
- viii) Environment Cllr Brown reported that there had been a meeting on 24th November. It is proposed to put 'Eco Tips' in the village magazines. The new Terms of Reference were **AGREED**.
