

DODDINGTON PARISH COUNCIL

Minutes of the Parish Council Meeting held in Doddington Village Hall on
Monday 8 December 2025

Present: Cllr Steve Coates (Chairman), Cllr Kevin Attwood, Cllr Kirsty Clark, Cllr Graham Cuthbert, Cllr Kevin Fraser, and Cllr Linda Lumsden; and Mrs Wendy Licence (Clerk).

Also present was Cllr John Britt, Chairman of Lenham Parish Council

Cllr Coates welcomed everyone to the meeting

1. APOLOGIES

Apologies had been received from Cllr Colin Jones: apologies accepted.

Apologies had also been received from County Councillor Rich Lehmann: apologies noted.

2. DECLARATIONS OF INTEREST

None were declared.

3. TO DETERMINE WHETHER ANY ITEMS SHOULD BE DISCUSSED IN CLOSED SESSION

None were identified.

4. MINUTES OF THE PARISH COUNCIL MEETING HELD ON 10 NOVEMBER 2025

It was **AGREED UNANIMOUSLY** to accept the minutes as a true record of the meeting. Cllr Coates duly signed the minutes.

5. MATTERS ARISING

War Memorial

Cllr Coates reported that Newnham Parish Council is willing to share the costs of the War Memorial maintenance.

Cllr Cuthbert reported that he had informed the volunteers the Council has agreed to cover the cost of replacement materials. The purchase of a new hedge cutter will not be progressed at the moment and one is available for loan. The timber measurements will be sent to SBCllr Thompson.

6. PLANNING MATTERS

i. Heathlands Garden Settlement Draft Supplementary Planning Document Consultation

Cllr Coates informed Members that Maidstone Borough Council had invited the Parish Council to comment on the Heathlands Garden Settlement Draft Supplementary Planning Document. Further to the discussion about this at the last council meeting, Cllr Coates had invited Cllr John Britt, Chairman Lenham Parish Council, to the meeting so that he could provide us with more information about the development. Cllr Britt explained the background and its linkage to two other sites. Maidstone Borough Council had identified three garden communities in its Local Plan; Heathlands, up to 5,000 houses (about which we were being consulted) and two other sites. Cllr Britt provided background and identified some key concerns. 1)the actual available land for building is 100-hectares of the 360-hectare site; this would cause the density of housing to rise considerably. 2. There was a lack of clarity

about when the infrastructure will be delivered and issues with the railway station. 3. the transport assessment is flawed; and 4. the water treatment works are unlikely to be built until 2040-45; and it is therefore likely that sewage will need to be tankered away. This could be 80-120 tankers per day.

Cllr Coates **PROPOSED** that the Council supports Lenham Parish Council and submit comments to Maidstone Borough Council; **SECONDED** by Cllr Lumsden: **5- FOR, 1- AGAINST: MOTION CARRIED.**

Cllr Coates thanked Cllr Britt for attending the meeting.

Cllr Britt left the meeting.

Cllr Coates reported that the Clerk is chasing Swale Borough Council for a date for a road sweep of the Old Lenham Road. Cllr Jones has chased KCC Highways regarding the

Ringlestone Road flooding near the water works and blocked soakaway, to no avail so far but will persevere.

It was **AGREED UNANIMOUSLY** to pay the Village Hall £90 in respect of hall hire (cheque no 1428).

11. SPEED WATCH

Cllr Fraser reported that Speed Watch sessions continue with encouraging results. More volunteers are needed.

It was **AGREED UNANIMOUSLY** to accept the quotation of £695.50 + VAT from Landscape Services for thirteen cuts of playing field
