Matters Arising from Previous Minutes

1) Tree Planting/Mrs W Davison B.D.C.

Chairman welcomed Mrs Davison to Meeting, who said that Bassetlaw Tidy Programme arose in 1986 at a Tidy Conference. She is now more well known and making progress slow but sure. Her job is to educate people, particularly children i.e. litter. She has visited every school, some of which are now doing projects. Next step is voluntary groups. Spring Clean Day, some 90 events taking place so far. Queen Mother is Patron. Set up Grot Spot Team who are routed round once a fortnight, although anything dangerous i.e. bottles and glass is picked up next day. Bags will be provided and also strimmer if you provide manpower/petrol. Skip could also be provided, giving if possible 4-6 weeks notice. Any areas cleaned up it would be appreciated if photo's could be taken of before and after. All rubbish cleared is examined so prosecutions can be made. Bottle Bank can be provided. Chairman to ask Mr Hyde of Bridge Inn for site. Will take .6th of a ton and is emptied regularly. Chairman pointed out that dyke could do with being piped. Fishermen pose a problem at Riverbank with rubbish. Litter bins could be provided at Fledborough and emptied by Grot Spot Team. One in Ragnall has bottom dropped out, new bin to be provided. Mr Gaisford asked for three bins for Dunham, sites to be arranged. 1/4/90 sees regular monthly cycle workings hours 9-1.00 p.m. Trees available for schools. Scouts to be asked for their help for Spring clean Day. Chairman thanked Bengali Tiger for all her help!

2) A57 Road

Public Meeting was held 2/2/90. Chairman read letter from Mrs J Hodson (Environmental Health). Brought to Meetings attention lorry parking on Main Road to be asked to cease parking (Mr Rose, Jubilee House, Dunham). Lorries also parking in lay-bye opposite Gauntley's. Cllr Atkinson to go and see Environmental Dept as District Cllr. Need to get registration numbers in future for lorries parked. Also brought up that lorries driving on the wrong side of the road at crossroads.

Cllr Plant pointed out that there were two divisions of opinion on the matter of the Bye Pass and requested a vote. After discussions it was agreed that the Council does not reflect an opinion as a Council - pursuit of a Bye Pass is lead by a body independent of the P.C.

It was decided to ask Mr Merville for the latest date possible for ordering trees for the season. Mr R. Sutton is willing to provide trees, stakes and land. Call Sub Committee Meeting next week. Mrs Barden said Mr Ashworth should be on Committee.

### Visit by Mr. Howarth of the Angling Federation

Owing to illness Mr. Howarth was unable to attend Meeting. It was reported that Mrs. Barden, Mrs Oakden and Mr. Gaisford had met a representative from National Rivers Authority to assess situation of litter at River Bank. It was also stated that Mr R Packer on Worksop 500219 and his Tidy Crew may be able to help. Land underneath Bridge NRA land. It was decided to invite Mr Howarth to next meeting, Cllr Plant proposed Sub Committee go down every Sunday and see Anglers. No seconders.

### Housing Young People, Visit by Mrs Puddy

Chairman welcomed Mrs Puddy to meeting. Mrs Puddy stated that the percentage return of survey was 57%, which was fairly supportive for a small development, about 7-8 units. Thought that housing now needed for young people. Also perhaps additional rented accommodation for bungalows, better chance for development outside village envelope, and are looking for approx 1 acre. First steps to determine suitable sites, get BDC approval and send out application forms to interested parties. All dealt with confidentially. P/C to help target possible candidates. Whatever % share split between the home buyer and the assoc, the % share would remain constant. Homes offered to those with a village connection i.e. born in village - parents want to live near family already in village etc. Homes offered to those within immediate parishes, if not taken - extended to include adjacent parishes. Need basically cheap land, right building contractor to determine unit costs. Once built, 6-8 weeks given to Housing Assoc to find occupier. 150,000 housing associations registered, sometimes 4-5 are wound up in a year. Could ask D/C if willing to support this issue, Mrs Puddy to write to Bruce Barnett of D/C informing them that there is a definite need. Cllr Atkinson proposed that a letter be written to D/C saying wish to proceed with a mixed development with their support. Possible preference Ragnall or Dunham for easy access to facilities, seconded Cllr Harris. All in Favour. Mrs Puddy to write to D/C on our behalf. Estimated £400 a month to repay mortgage at moment. Rents in Notts. £45 a week. Should call Public Meeting, use appropriate form to ask what sort of house they require. Copy of letter sent to be given to Cllr Atkinson. Chairman thanked Mrs Puddy for attending and her advice.

### Approval of Previous Minutes

Cllr Cook brought to Meeting attention that the development at Marsh Lane was primarily to resolve bus turning problem, and then to enhance the area to include picnic facilities.
