- 2. PREVIOUS MINUTES APPROVED
- 3. MATTERS ARISING
 - a. Letter received from Mr. And Mrs. Carlin to the Parish Council objecting to the proposed development behind Fox View.
 - b. Letter from Savills on behalf of Mr Wyatt with regard to land beyond Huntley Down. P.G. not in a position to update them at this stage but they are welcome to sit in on a meeting when this changes.

- 5. PLANNING GROUP WORKSHOP DAY All agreed it had been an excellent day with many issues/ideas discussed which has enabled us to move forward to the next stage.
 - a. PROGRESS FOLLOWING WORKSHOP The majority of reports are now written up and onward actions needed as follows.
 - i. Flooding---Formulate a letter to the E.A., Flood Risk Management Team at D.C.C. and Wessex Water to seek their views on the draft policy, including grey water systems. SC to e mail GC to ask if she is able to carry this out and to liaise with JW and RM with regard to mapping.
 - ii. Character---Mapping of footpaths and missing links. QM to deal with this. MH will contact grant application with regard to funding for transport consultant.
 - iii. Parking---Discussed parking spaces per house plus possible community parking areas? It was decided that ideally 2 spaces per 1 and 2 bedroom properties and 3 spaces for 3 or more bedroom properties. Ronald to draft a policy.
 - iv. Housing---To find details on the position of any covenant placed on properties. Jo to supply legal documentation.
 - v. Business and Employment---T defer discussion until January meeting when SG and DG are present.
 - vi. Facilities---Awaiting response from G.P. Practice regarding any possible future plans to re-build the main surgery in Milborne St Andrew. No further action needed to date.
 - vii. Renewables---Agreed no further action required as adopting North Dorset Policy.
