Shropshire Councillor Richard Huffer gave an update on the Health Issues in Shropshire concerning service provision at Shrewsbury, Telford and Ludlow and on which there had been a recent public meeting at Ludlow attended by Health Service Representatives and the local MP Mr P Dunne.

Cllr Huffer also gave an update on the consultations concerning the provision of Post Office services at Clee Hill where an application had now been submitted by the existing tenant of the Spar shop to take over the services at Clee Hill. There may be cost implications for which the Parish Council may be asked for a grant towards any conversion works.
