North Dorset Local Plan Part 1 Adoption Statement

Notice is hereby given that North Dorset District Council adopted the North Dorset Local Plan Part 1 on 15th January 2016 in accordance with the above regulations.

The North Dorset Local Plan Part 1 ("the Plan") replaces or retains 'saved' policies of the North Dorset District-Wide Local Plan (1st Revision) 2003 to 2011 as listed in Appendix A of the adopted Local Plan Part 1.

The Plan sets out the overarching framework for the future planning of the District to 2031 and comprises a long-term spatial strategy, strategic objectives and planning policies, including the identification of broad locations for development at the main towns, and the allocation of a Strategic Site at Gillingham. The Plan also includes development management policies and establishes a framework for monitoring.

The Plan has been subject to examination by an independent Inspector appointed by the Secretary of State. It incorporates the Main Modifications recommended by the Inspector (as set out in the appendix to his report) and Additional Changes proposed by the Council (detailed in a separate schedule).

Any person who is aggrieved by the adoption of the Plan may make an application to the High Court under Section 113 of the Planning and Compulsory Purchase Act 2004 on the grounds that:

- the document is not within the appropriate power; and/or
- a procedural requirement has not been complied with.

Any application to the High Court must be made no later than the end of the 6 week period from the date of adoption (i.e. Friday 15th January 2016).
