NOTE 1: The roadway coloured brown referred to is tinted yellow and tinted mauve on the title plan

NOTE 2: To the extent that the rights granted by the above Deed are over the land tinted mauve on the title plan, being land registered with Possessory Title only, the benefit of such rights is excluded from the effect of registration with title absolute.
