#### 1. APOLOGIES

Apologies were received from Cllrs Mick Bowles and Chris Cope.

#### 2. DECLARATIONS OF INTEREST

There were none.

#### 3. MINUTES FROM PREVIOUS MEETING

The Minutes of 27<sup>th</sup> January, having been agreed, were signed by the Chairperson. It was requested that Minutes were sent to Members in both .doc and .pdf formats.

#### 4. OPEN SESSION FOR THE PUBLIC

Ms Weaver asked for an update on the petition to for traffic lights to be installed at the Main Street/A6097 junction. Cllr Jackson informed the meeting that he had presented the petition to the Transport & Highways Committee earlier in the month and that he would be presenting it to the full Council Meeting on the 25<sup>th</sup> February.

Cllr Jeffery spoke with regard to the planning meeting to consider the Marehill application. She stated that she had great difficulty in being allowed to speak. Eventually she was heard and with support from two District Councillors, the application was postponed until the next meeting.

TC informed Members that no reply had been received from Andrew Muter. It was therefore agreed that TC should write a formal complaint to NSDC and should also write to MP Robert Jenrick.

# 5. TRAFFIC & HIGHWAYS MATTERS

It was noted that the work in Brookfield Close had not yet been done, but residents were already using the area in question for parking. It was also noted that some residents were using the full length of gardens to park and this causing some "grief".

Cllrs noted that various ground levels in Lowdhams were being raised and possibly lowered. It is possible that the average height is being increased. It is unknown whether the new heights have been agreed by NSDC Planning. Cllr Jackson will pursue.

Cllr Jackson stated that the 1.9% increase in business rates and council tax are generally felt to be reasonable and that the East Midlands is the richest area in the country. NSDC is moving from Kelham Hall to a site behind the Cattle Market. B It was also noted that there had been no progress with plans for drainage in the Main Street / Peck Lane area.

Cllr Jeffery gave thanks to all those concerned with the tree-planting ceremony on Saturday. It was deemed to be a great success.

# 6. ENVIRONMENTAL MATTERS

Cllrs Jeffery and Everington have consulted NALC about the legal aspects and requirements of the grass-cutter.

# 7. THE RIVERSIDE PROJECT, GRAVEL EXTRACTION AND FLOOD ALLEVIATION

Cllr Platten gave a verbal report on the work of the Riverside Trust – this is presented at Appendix A. TC has been in contact with Heather MacKenzie of the Canal and River Trust (CRT) who is addressing the issues raised over the past year or two. Ms MacKenzie feels that the trees cut down recently on Gunthorpe land were not cut down by the CRT, but will investigate. TC was asked to forward the Riverside plans to Cllr Platten. There is to be a meeting of GEFAG on Friday 11<sup>th</sup> March.
