Draft Minutes of the Parish Council Meeting held on Wednesday, 16th February 2022 at 7.30pm in the Main Hall, South Muskham Village Hall

In the absence of Councillor Catanach, the meeting was chaired by the Vice-Chair, Councillor Shearing.

96.21/22 Apologies for Absence and Declarations of Interest

Apologies – Received from Councillor Catanach
Declarations of Interest – There were none made.

Open Session

The Chair suspended the meeting at 7.34pm for the open session.

Councillor Laughton referred to the consultation on the experimental 40mph speed limit. The monitoring by the community speedwatch team and Police had been stopped, as the Legal Team at the County Council had advised no enforcement could be taken in an experimental zone. Comments regarding the Notice issued by Via East Midlands to confirm the order have to be submitted by 11th March 2022. Speed monitoring could recommence if and when the order was confirmed. If any objections were received, they would be considered by the Cabinet Member for transport.

The proposed reduction in the speed limit was good news for the village and would improve road safety for all road users.

Councillor Jarvis referred to the complaint from a resident regarding the waste collection lorries driving along the verge. Councillor Mrs Saddington presumed that this would be due to safety concerns for the operatives and the speed of the traffic. Councillor Laughton reiterated that stones should not be placed on the highways verge. The Clerk had taken the matter up with the District Council's Trade Waste team, and fed back to the resident.

Lorries waiting to enter British Sugar had been causing issues on the Great North Road, as they were backed up on the road. If this happened again Members were asked to let Councillor Mrs Saddington know. The Clerk to also raise direct with British Sugar.

Councillor Laughton advised that the County Council would be arranging two Parish Council events in May to update on the devolution of powers outlined in the Levelling Up White Paper. The County Council was one of 7 pilot counties chosen to go down the devolution route. The County Council were in negotiations with Derbyshire to agree a Mayoral district, which would effectively bring in £5-7 billion to the area plus it would give the County Council control of the Local Enterprise Partnership.

Councillor Jarvis referred to a number of white bags that had appeared on Crow Lane and was concerned that it may be illegal dumping. Councillor Brown to make further enquiries and feedback to the Clerk.

Councillor Mrs Saddington referred to recently problems along the Nottingham to Lincoln line. A copy of an email sent to Network Rail to be forwarded to the Clerk for information.

The Chair reconvened the meeting at 7.56pm.
