1. Respective responsibilities of the body and the auditor

2. 2016/17 External auditor's report

Except for the matters reported below on the basis of our review of the annual return, in our opinion the information in the annual return is in accordance with proper practices and no other matters have come to our attention giving cause for concern that relevant legislative and regulatory requirements have not been met.

The Council has stated in Section 1, item 5, that it has carried out a risk assessment and taken appropriate action to manage those risks. Additionally, the Council has stated in Section 1, item 1, that it has put in place arrangements for effective financial management during the year. In light of further information and responses from the internal auditor however, we believe that the Council should have answered no to both assertions 1 and 5. The Council needs to ensure that it regularly monitors budget process and it carries out a risk assessment for 2017/18.

Other matters not affecting our opinion which we draw to the attention of the smaller authority:

We were required to return the Annual Return to enable the Council to correct the following:

A. Initially fixed assets at Box 9 were valued on a different basis in 2016/17 to 2015/16.

In future the Council should ensure that the Annual Return is accurate and complete.
