1 Respective responsibilities of the body and the auditor

Our responsibility is to review Sections 1 and 2 of the Annual Governance and Accountability Return in accordance with guidance issued by the National Audit Office (NAO) on behalf of the Comptroller and Auditor General (see note below). Our work **does not** constitute an audit carried out in accordance with International Standards on Auditing (UK & Ireland) and **does not** provide the same level of assurance that such an audit would do.

2 External auditor report 2017/18

On the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

Other matters not affecting our opinion which we draw to the attention of the authority:

We note that the figures in Section 2 include 100% of the transactions and balances of the Parishes of Longframlington & Brinkburn Joint Burial Committee. In future years, the two councils should follow the guidance in the Practitioners' Guide (restating the prior year figures as appropriate) and show the appropriate shares of income, expenditure, assets and liabilities (including any year-end balances) within their own accounts.

The AGAR was not accurately completed before submission for review. The Box 9 figure for the prior year contained a transcription error which has been amended.
