The Chairman advised all present that the meeting was being recorded.

0621 Committee Vice Chairman

Cllr Ms White was unanimously elected as Committee Vice Chairman.

0622 Apologies

Apologies were received from Mrs Lee, Lynch, Mallard and Scott.

0623 **Declarations of Interest**

Cllrs Mrs Brooks, Mrs Hurst and Ms White, as serving members of Newark & Sherwood District Council, declared a personal interest to any issue relating to the District Council.

0624 **Public Participation**

The meeting was closed to take public comments but those present did not wish to speak. The meeting was re-opened.

0625 **Planning Applications**

The following planning applications were considered and approved subject to the following comments:

22/01672/FUL Change of use - greengrocers to beauty salon
Street & alterations to the front elevation

Some concerns were expressed about the loose stone chippings that are proposed for installing to the front of the property as these will spill over onto the pavement.

22/01770/S37 Vary condition 2 to 21/01559/S37

22/01786/HOUSE Single storey extension to front elevation

The following planning application was considered and objected to with the following comments:

22/01726/FULM Residential development of 94 dwellings Highfields School Whilst members acknowledged the reduced number of dwellings from the previous application, the proposal is still considered to be far too intensive for the site and out of keeping in general with the style of the existing properties which surround the school grounds. In addition to this there are still a number of other concerns, namely

from the additional traffic that will be created at an already busy and hazardous junction close to the bridge on London Road, an adverse impact on neighbouring properties caused by loss of privacy, and the loss of mature trees, a number of which are subject to Preservation Orders.

Members were also due to consider application number 22/01598/S73M - Vary conditions re site access Welcome Break Services on Great North Road Fernwood, but decided on balance to abstain and not respond to the application which is outside of the parish.

0627 Correspondence/Information

The following items of correspondence/information were noted:

- 1. The District Council's Enforcement Department had responded to an alleged removal of a hedge and erection of a fence beyond the property boundary at number 1 Elton Close. Although a breach has occurred as the fence is higher than allowed under permitted development, the County Council found no concerns and the District Council has deemed that no further action is necessary.
- 2. An appeal has been lodged against the planning refusal to build 2 dormer bungalows at 36 Bullpit Road (application number 22/00954/FUL).
- 3. Barnby in the Willows Parish Council had enquired whether this Council was aware of, or had any comments regarding an application for the formation of an access to an outbuilding at Chestnut Lodge on Barnby Road? The application is for a Lawful Development Certificate and the District Council does not consult Parish Councils about these.
