223/23 APOLOGIES FOR ABSENCE

Apologies for absence were received from Councillor Bullock, Berrisford, Daly, Karling and Speed.

224/23 DECLARATIONS OF INTEREST

All Members present declared personal interests in the subject matter Application No: 23/00591/FUL, as they were residents of the Parish and used the Village Shop.

225/23 PLANNING MATTERS

The Parish Council considered the following two Planning Applications which related to the Parish:-

(i) Application No: 23/00137/FUL - Land Off Church Lane Betley Proposed Development: Siting of cabin to be used as agricultural workers dwelling for temporary period. http://publicaccess.newcastle-staffs.gov.uk/online-applications/PLAN/23/00137/FUL

RESOLVED:

The Parish Council unanimously objects to this proposed development, as the proposed farming system does not amount to a financially viable agricultural enterprise. The proposal is not consistent with planning policy. There is no justification for a dwelling, even a temporary dwelling, or for a caravan or mobile home. The site was inspected on 7 August and there was no evidence of any agricultural or horticultural activity taking place, or having taken place, on the application site.

[In the professional opinion of one of the Parish Council members, who is a Chartered Surveyor, there is no prospect whatsoever of the proposed enterprise becoming financially viable. The labour required to service the enterprise is minimal and falls well short of a full time labour unit, which is the minimum criteria required to support such development.]

(ii) Application No: 23/00591/FUL – Betley Post Office, Main Road, Betley: Retrospective application for a timber structure. http://publicaccess.newcastle-staffs.gov.uk/online-applications/

RESOLVED:

That the Parish Council supports this application and several Members added that the entire area was much improved and that the structure was a significant improvement on what was there previously.

226/23 REMEMBRANCE SUNDAY

230/23 INVOICE FOR PAYMENT - L RIMMER

RESOLVED

That the payment of the invoice for the maintenance carried out on the Memorial Garden in July 2023 in the sum of £180.00 to L Rimmer, be approved.

231/23 LIGHTING

Councillor Bettley-Smith reported that during the dismantling of the Coronation lighting festoon, several bulbs fell out along with their sockets. These were now considered to not meet health and safety standards.

RESOLVED

That Councillor Bettley-Smith be given delegated authority to purchase a replacement festoon which meets the required standards for such lighting, in the sum of £331.20.
