## 1802. Reports By Councillors on Outside Bodies.

**CLP.** The Chairman of the Community Led Plan Steering Group, Mr. David Crwys-Williams, addressed the Meeting and reiterated the contents of the pamphlet which had been circulated at the end of last year highlighting four priorities.

Action Teams will be formed for each of the four priorities;

- Traffic and Roads.
- Faster, affordable broadband.
- Preferred housing development guidelines.
- Facilities and activities for young people.

Discussion took place on faster Broadband. It was reported to the Council that only 24 of a possible 104 households has registered for faster broadband in the recent consultation.

It was thought that if the community wished for a faster service, this response did not send a clear message for possible upgrading. It was suggested that it could be an advantage if Ashendon worked jointly with Westcott Venture Park to pressurise the relevant authority for improvement. Councillor Pimm to contact the Venture Park to see if this is a possibility. Councillor Pimm also to work in conjunction with Mr. David Crwys-Williams and the CLP. Steering Group.
