#### **Members of the Public:**

- a) The meeting was attended by Mr R Wallace Salop Medical Services (UK) who presented details about the defibrillator lease scheme which costs £365 per year per unit and includes annual maintenance and replacement of batteries and pads. Cabinets for the defibrillators can also be leased for a three-year period at a cost of £265.
- b) A member of the public attended the meeting to express concern about the overgrown hedges along Clun Road which is causing mobility users and mothers pushing pushchairs to use part of the busy highway due to the narrowing of the footpath.

#### 24/18 Chairman's Items:
