9. **Cotswold District Council's Local Plan Update Consultation (Paper 1):** To review recommendations from Cllr Davis on responses to the Consultation by 7th April deadline. Cllr Davis to submit a paper for consideration at the Council meeting. When making a response to the consultation, CDC's Neighbourhood Plan Officer suggested considering the Parish Council's Neighbourhood Plan priorities alongside the draft Local Plan.

10. **Competition & Markets Authority (CMA) investigation into Leasehold, Freehold and Estate**

Management: Cllr Davis outlined the findings of the report and its recommendations to government, including:

- requiring councils to adopt amenities on all new housing estates.
- introducing enhanced consumer protections for homeowners on existing privately managed estates – including making it easier for homeowners to switch to a more competitive management company.
- establishing a New Homes Ombudsman as soon as possible and setting a single mandatory consumer code so homeowners can better pursue homebuilders over any quality issues they face.
