- 5. **21/02176/HSE 4 Wheelwrights, Woolton Hill, RG20 9QW.** Erection of a proposed two-storey rear / side extension.

The Committee confirm the comments made in August and September and reiterated that whilst it has no inherent objection to the extension of the property, there continues to be concern regarding the proposed scale of the development; that it may be out of keeping with surrounding properties and too large for its environment.

10. **T/00499/21/TPO - Woodnook Lodge, Woolton Hill, RG20 9XF.** T1 Copper beech: fell.

As the tree in question does not appear to be diseased the Committee stated it would prefer that, if possible, the tree be managed rather than felled.

11. 21/02076/HSE - The Old Rectory, Woodhay Downs, East Woodhay, RG20 **0AL**. Installation of Solar Panels on internal main and lower roofs of house and rear facing roof of pool house.
