25.192 Declarations of Interest

25.193 Open Forum

There were no members of the public in attendance.

25.194 Minutes

The minutes of the Parish Council meeting held on Monday 10th November 2025 were agreed and signed by the acting Chair Cllr Carole Paternoster.

25.195 Clerks Report

- The locks on the main door of the Hall have been changed. Clerk will notify Councillors how to access the building.
- The Clerk requested approval to attend NALC Course Beyond the Precept: Funding solutions for smaller parish and town councils Feb 11th £35. This was approved by council.
- Request has been received from Ascott House to advertise in Parish Newsletter. ACTION: Clerk to redirect to Village Life publication.
- Dog bin Local dog walkers have noted that the bins are no longer over flowing as the dog
 walking businesses have been taking dog waste elsewhere so no longer wish to contribute to a
 new bin.
- Clerk is attending FOI training this week and Assertion 10 training.
- Clerk has received comments from public regarding the streetlight opposite Yew Tree Cottage being very dark due to over hanging trees. ACTION: Clerk to contact owner and request cutback of trees.
- Quote has been received to repair the village gate sign at Buckland Wharf for £395.98. Given budget constraints Clerk to chase Buckinghamshire Council to repair and BPC to review in January.

SSE Account

Payments to SSE for street lighting have increased due to introduction of half hourly meter readings, instead of estimated readings. This is part of a Mandatory settlement relating to increased standing charges, and also increases in government taxes. As a result there will be a budget overspend of approximately £1500 this year. This will also impact the future budget and costs for next financial year. ACTION: Clerk to see if alternative contracts can be found and share details with councillors, and also to ascertain if switching lamps to LED would be cost effective

25.197 Planning Applications/Matters

- PL/25/3484/FA Lodge Farm House, Buckland Wharf, Buckland, Buckinghamshire, HP22 5LH
 Application type: Provision of vehicular access with associated works. BPC have now been made
 statutory consultee on this application alongside Aston Clinton Parish Council. It was noted that
 Buckinghamshire Highways have commented that access to two current properties, The Lodge
 and Lodge Farm would be acceptable but not for any further development on the site.
- Occupation of Canal Plot in Lower Buckland Nothing to report.
- To consider any planning applications received since 1st December 2025. There have been no further planning applications.

25.198 Thames Water Pumping Station Update

Thames Water have contacted Buckland Parish Council to let them know that they have been reviewing possible locations for the site and are in active discussion with landowners. Preapplication will be submitted to Buckinghamshire Council in January, and a meeting will be arranged with Buckland Parish Council, along with a public drop in session at an undisclosed location.

25.199 Consultations

Buckinghamshire Fire Service consultation on reduction of fleets. **ACTION: CIIr Carole**Paternoster to complete on behalf of Buckland Parish Council, mentioning the need to maintain current service levels due to increased housing allocations in the Aylesbury area.

25.200 Roads and Transportation

Updates on:

- Buckland Road Buckinghamshire Council have confirmed they will supply temporary signs that can be used on Buckland Road.
- Tring Hill / Buckland Wharf Traffic calming letter will be sent in January responding to reply from Laura Kyrke-Smith MP.

 Speedwatch group – Thames Valley Police have requested Speedwatch equipment back. The Buckland group has been disbanded due to lack of volunteers.

25.201 Maintenance of Land Holdings

To receive reports and agree any actions relating to the Parish Council's Land Holdings:

- a. Burial Ground– Yellow rattle was sown by volunteers from The Chiltern Society and the wildflower area has been marked out to prevent grass cutting.
- **b.** Lower Buckland /Community Orchard Yellow rattle was sown in the orchard by The Chiltern Society. Replacement trees have been planted. Clerk to look at possible community planting event in New Year. 70 hedge whips have died. It was agreed to spend £100 on replacement whips, tree protectors and stakes for new trees that had been donated.
- c. Primrose Copse and Allotments UK power networks have visited Grass keep site and confirmed that dead tree can be removed. They will need to be notified when work is carried out to deenergise the power lines. **ACTION: Clerk to investigate cost of tree removal.**

25.202 Footpaths and Environment

To receive reports and agree any actions

- Devolved Services Clerk is in discussion with devolved services regarding grass cutting maps.
 Buckinghamshire Council have confirmed that they are removing sign and bollard cleaning from the agreements. Future funding will be in line with inflation.
- Footpaths & Bridleways a complaint had been received regarding the overgrowth at the footpath
 at the end of Peggs Lane. This has already been reported to Buckinghamshire Council and is
 awaiting clearance.
- Fix my street Issues have been reported and shown as closed yet not been actioned. Cllr Bowles reported that a working group has been established to review the Fix My Street platform.
- Buckland Wharf streetlight issue Buckinghamshire Council have said the external contractor will
 not be able to carry out repairs to the underground cable until March 2026. In the meantime, they
 will try to repair individual columns.
