North Lincolnshire Council would like to consult with the parish council regarding proposals to make amendments to some of the existing speed limits on our A class road network, in particular the proposals on the A18, which are listed below:

30mph speed limit

Main St, Melton Ross (Airport side) from the existing 30mph Speed Limit - to replace the existing 50mph Speed Limit with a 30mph Speed Limit in an easterly direction for a distance of approximately 60m

40mph speed limit

Melton Ross (west of the junction with B1211) – to extend the 40mph Speed Limit in a westerly direction for a distance of approximately 105m, replacing a section of the existing 50mph Speed Limit
