**18/04398/APP** – Hillside Top Stables, Turweston Hill Farm. Erection of equestrian aqua rehabilitation unit (plunge pool) and associated works. **Application withdrawn**  
**19/00412/ATC** - Village Hall Main Street Turweston Buckinghamshire NN13 5JU. Cut back Yew Tree to a height of 1.50 metres.  
**19/00439/APP** – 1 High Elms, Oatleys Road, Turweston. Demolish garage and erect single storey rear and side extension. **No objection.**  
**19/00554/ATC** – The Post Office, Main Street, Turweston. Cherry 10004 - Group of 4 trees prune 1-2 m clear of shed and house, crown lift the tallest trees to 2 m all round.

**19/00559/ATC** – Turweston Manor, Main Street, Turweston. Unknown Species 8510 - Crown clean remove dead, damaged and hung up branches from crown and prune 2 m clearance from building.

**19/00551/ATC** – The Orchard House, Main Street, Turweston. Willow 10005 - Crown lift to 3 m all round, prune 1-2 m clear of shed and crown clean removing all dead, damaged and hung up branches. Yew 10006 - Crown clean removing all dead, damaged and hung up branches. Unknown Species 10007 - Fell at waist height small tree trained to grow over one side of arch, support has failed for archway over the path. Lime 5522 - Crown lift to 2.5 m all round and hedge cut shrubs back to boundary.

**19/00562/ATC** – Court Cottage, Main Street, Turweston. Cherry 7365 - Crown lift to prevent trees contacting neighbouring garage. Sycamore 7366 - Crown lift to prevent trees contacting neighbouring garage. Cherry 7368 - Fell and remove due to lower stem decay, caused Ganoderma. Cypress 7369 - Crown clean, remove dead, damaged and hung up branches. Yew 7371 - Fell and remove young tree growing out of the wall (out grown location). Cypress 7994 - Crown clean, remove dead, damaged and hung up branches, failed limbs facing barn building.

**19/00558/ATC** – Northfield House, Main Street, Turweston. Ash 8334 - Remove 2 of the low main structural limbs road side. One is growing around and through the wires the limb has Inonotus Hispidus bracket on. Cypress 8336 - Crown clean remove all dead, damaged and hung up branches. Maple 8337 - Fell at ground level, compressed main union containing decay fungi.

**19/00561/ATC** – 3 Manor Cottages, Main Street, Turweston. Yew 11526 - Group of 3 trees 2 Yew and 1 Cherry by side gate, prune 0.5 m clear of wall and crown lift over path to a height of 2 m. Pollard cherry at 3-4 m and leave as a habitat pole %90 of the crown is dead.
