3.0 Public involvement session: (Agenda Items only) Speed of traffic through the village was raised as matter of concern by a local resident. The Ludlow end of the village was of particular concern with two very difficult exits onto the B4365 which although assisted by mirrors, still proved very difficult to exit from safely due to the speed of approaching traffic. Several measures were discussed, including white gates/ welcome signage/flowers to indicate entering a residential area, speed activated signs and a side mounted radar to gather useful data as well as training for a small group of volunteers to carry out speed checks.
